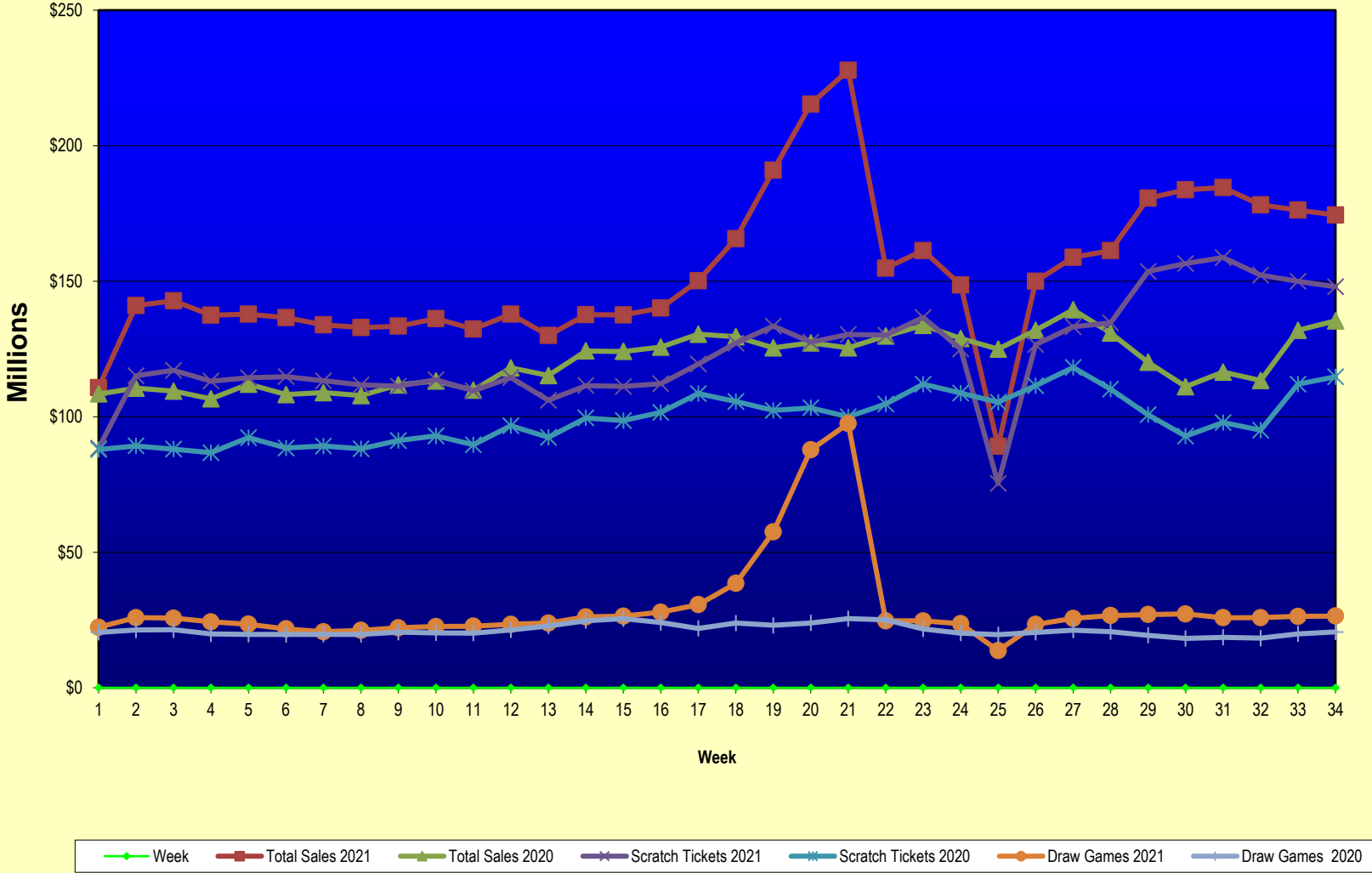

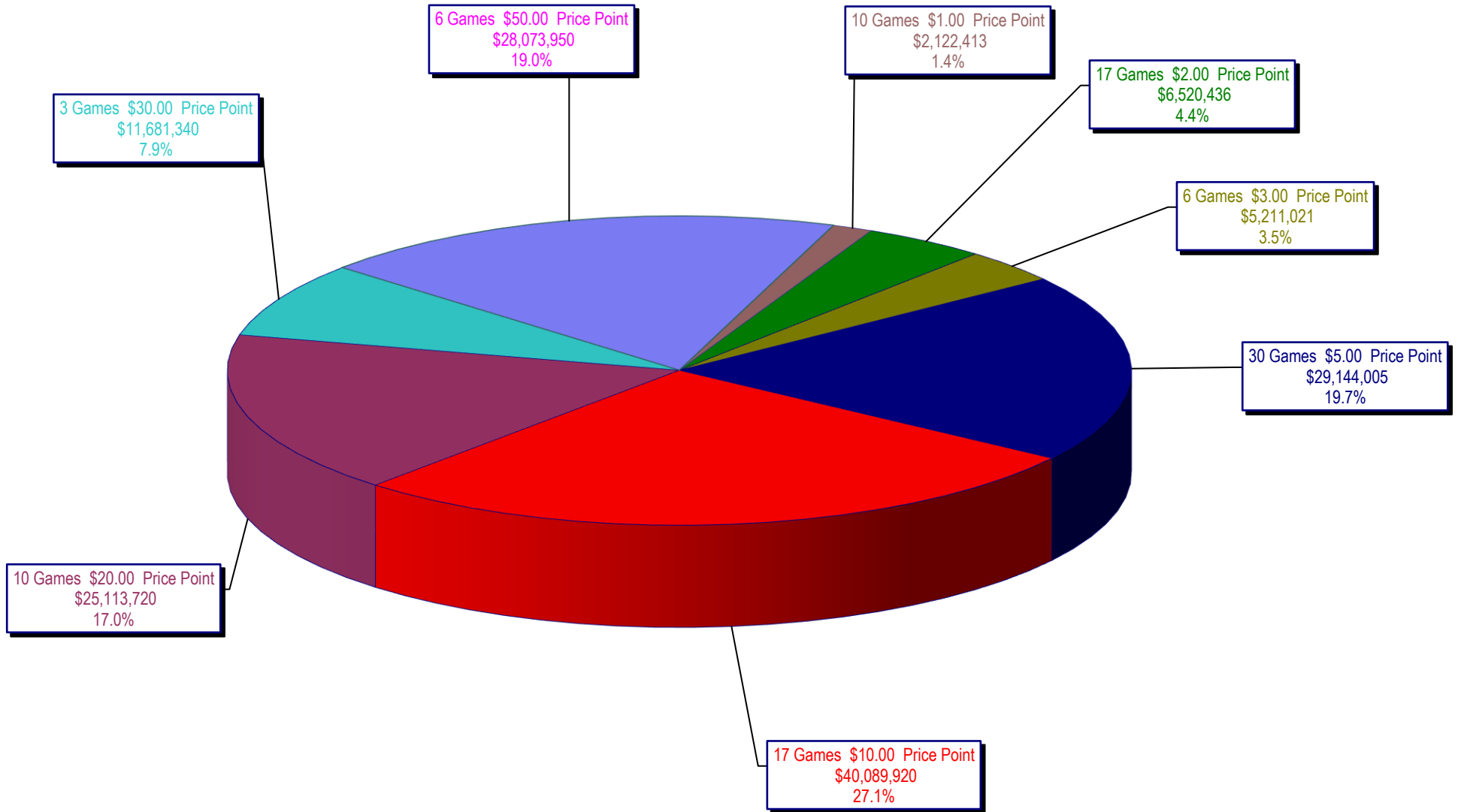

Texas Lottery Commission Fiscal Year Over Year Change in Sales

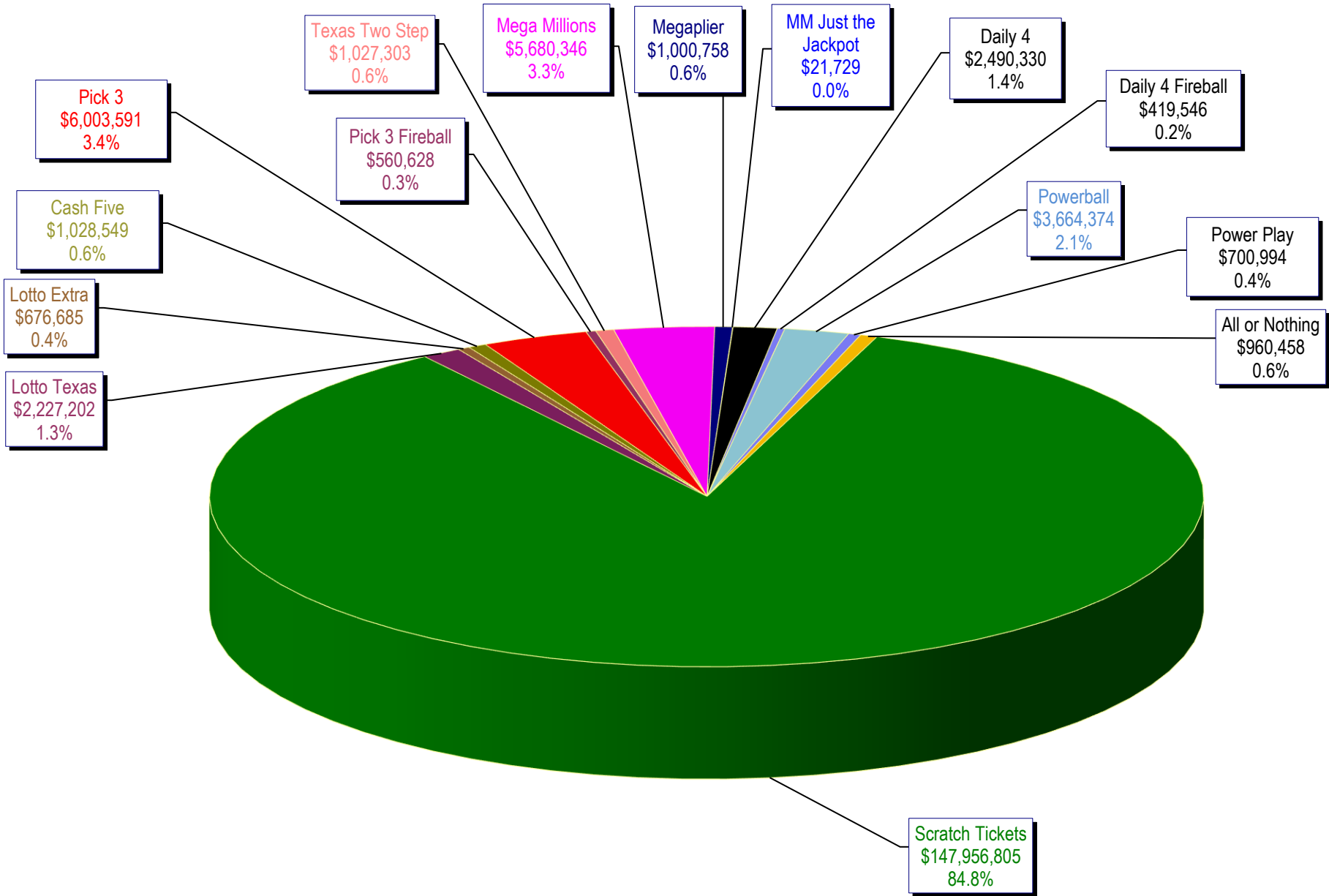
